- \$750 per 10x20 space. **Vendor must contain exhibit & merchandise in provided 10x20 space or will be charged additional fees.** (If paying by credit card, there is a 3% additional convenience charge.)
- There are **NO REFUNDS**, regardless of weather or any other circumstances.
- We do **not** provide tents, tables, chairs, or electricity.
- Vendor credentials and parking instructions will be given at check-in.
